

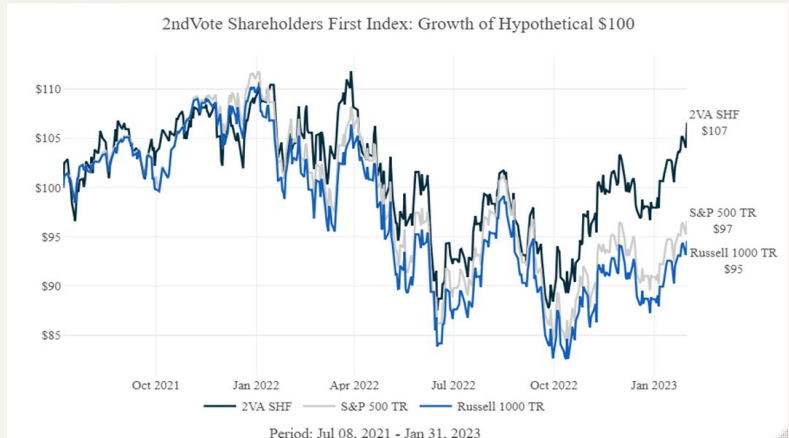
### OBJECTIVE

### INDEX APPROACH



#### Starting Universe & Stock Scoring

- Start with profit-focused large- and mid-cap US companies passing the initial “neutral” screen
- Method identifies 12 company characteristics that we believe may offer insight on performance based on monetary environment
- Top-Down: Defines the prevailing Federal Reserve monetary environment, as expansive, restrictive or indeterminate
- Bottom-Up: Score companies on these 12 financial metrics; rank based on the then-current monetary environment



#### Composition & Weighting

- Select the 50 stocks with the best financial position score (based on the 12 predictive financial metrics) under then-existing monetary conditions
- Each stock is weighted on its financial position score, i.e., its ability to prosper under prevailing monetary/economic conditions



#### Index Portfolio & Rebalance

- 2VA Shareholders First Index consists of 50 politically/socially neutral stocks that we believe can provide optimal performance under then-current monetary/economic conditions
- The index is designed to be rebalanced under four scenarios:
  - 1) firm financial metrics are updated
  - 2) the monetary environment changes
  - 3) Analytics score changes
  - 4) every 6 months, if no changes.
